#### Document Categories:

- (2) **General:** general purpose information type documents that contain information relevant to all components of the Telenet Wholesale Reference Offer.
- (3) **Broadband:** Documents that contain information relevant to the Broadband component of the Telenet Wholesale Reference Offer: Reference Offer Broadband Services (ROBB). Please note that, if the beneficiary desires to make use of the implementation of the interactive data return path of the Telenet Wholesale Reference offer Basic TV Annex Interactive Services (AIDTV) via the Telenet HFC network, specification and certification documents listed in this category broadband also apply to the category iDTV.
- (4) **TV:** Documents that contain information relevant to the TV component of the Telenet Wholesale Reference Offer.

- (6) **Technical Processes:** Documents that contain information on technical interaction procedures between AO and TLN in order to allow AO to make use of the Telenet Wholesale Reference Offer.
- (7) **Process:** Documents that contain information on Operational procedures & processes between AO and TLN in order to allow AO to make use of the Telenet Wholesale Reference Offer.
- (8) **Miscellaneous:** Documents that contain general purpose information on the Telenet Wholesale Reference Offer not belonging to one of the above specific categories

- (10) **Specification (SPEC):** Specification type documents (-SPEC) are documents specifying logical/physical interfaces/protocols, etc., to which AO equipment/systems need to comply. These documents include the certification test items.
- (11) **Certification (CERT):** Certification type documents (-CERT) describe the certification process and methodology.
- (12) **Technical Processes (TPRC):** Technical Process type documents (TPRC) describes technical procedures for exchanging information and interacting between Telenet and the AO.
- (13) **Operational Processes & Procedures (OPRC):** Operational Process type documents (OPRC) describes operational procedures for exchanging information and interacting between Telenet and the AO.
